I understand that the risk of becoming exposed to or infected by COVID-19 during attendance at St. Aloysius School or participation in an Activity may result from the actions, omissions or negligence of myself and/or others including, but not limited to, St. Aloysius School employees and volunteers; third-party service providers; other students and visitors at the St. Aloysius School; and participants in an Activity and their families.
